Testing Calendar Requirements

Prior to the first day of school, districts must post required testing calendar information on the district website and, if practicable, the school websites. Districts may choose how to format the information, and it should be easily accessible to students and families. These requirements have not changed from last year. For more information, refer to the Aug. 16 Assessment Update or the 2016–2017 Procedures Manual (PearsonAccess Next > Resources & Training > Policies and Procedures).

In planning their testing schedule, districts may request MCA Testing Time Reports from Pearson for the 2017 test administration. These reports provide cumulative testing time information by student and test. Some districts have found these reports helpful in determining the actual time students spent testing. To request a spring 2017 district report, contact the Pearson help desk at (888) 817-8659 or submit a Pearson help desk request. Districts can expect the reports 4 to 5 business days after the request is made.

2017–2018 College Entrance Exam Requirements

Based on 2017 legislation, districts are still required to offer a nationally recognized college entrance exam during the school day to students in grades 11 and 12. Districts can receive reimbursement for students eligible to receive a free or reduced-price meal and may require a student who is not eligible for a free or reduced-price meal to pay the cost of taking a nationally recognized college entrance exam.

There are two nationally recognized college entrance exams available to districts: the ACT and the SAT. Districts must contract with the test vendor directly. Test dates and registration deadlines are determined by the vendor.

Removal of Reporting Groups in PearsonAccess Next

On Tuesday, Sept. 5, the reporting groups from 2016–2017 will be removed from PearsonAccess Next, and the reporting group functionality will be unavailable for districts. Reporting group functionality for 2017–2018 will be available for districts at the end of January when test eligibility for 2018 is loaded into PearsonAccess Next. Additional reporting group information will be available in a future *Assessment Update*.

WIDA Screener Update (repeat)

There are three approved English Language Proficiency (ELP) screeners in Minnesota: the WIDA Screener, the Kindergarten W-APT, and the Kindergarten MODEL. Districts should make the transition to the WIDA Screener by Thursday, Aug. 31, which is when WIDA will no longer support W-APT in grades 1–12 and remove related resources from its website.
