## College Entrance Exam Reimbursement Payments

Districts who entered reimbursement requests in GRR by Sept. 15 for 2016–2017 college entrance exams will receive payment via the regular state payment process this week. These payments are generally deposited into the account the state has on file for the vendor number associated with the payment. The invoice number, or ID, is "GRR-Reimbursement." You can see the amount to be sent in the Final Student Amount report in GRR under Reimbursement Reports.

Note: The Status Date is the date the student took the assessment. If a district left this blank, it defaulted to the date the request was made. Districts that recently requested reimbursement may have inadvertently made a request for the 2017–2018 school year if they left the Status Date blank. ## Benchmark Reports Available in PearsonAccess Next

The 2017 Benchmark Reports are now available in PearsonAccess Next under Reports > Published Reports. Use these reports to help identify relative benchmark performance compared to expected performance based on overall scores. For subject-specific information, see the <u>2017 Benchmark Report User Guides</u> (PearsonAccess Next > Reporting Resources > Additional Reporting Resources). Benchmark reports are not produced when student counts at the school or district level fall below 20.

### 2017–2018 College Entrance Exam Administration Details

Based on 2017 legislation, districts are still required to offer a nationally recognized college entrance exam during the school day to students in grades 11 and 12. Students must be offered the opportunity but are not required to participate. Districts can receive reimbursement for students eligible to receive a free or reduced-price meal and may require students who are not eligible for reimbursement to pay the cost of taking the exam.

The ACT and SAT are the two nationally recognized college entrance exams available to districts. Districts must enter into a contract directly with the test vendor. Test dates and registration deadlines are determined by the vendor. See the following for more information.
