2017 Legislative Changes Regarding College Entrance Exams

Recent legislation regarding Minnesota Statutes, section 120B.30, subdivision 1e, changed the reimbursement of college entrance exams. Districts must continue to provide students the opportunity to participate in a college entrance exam on a school day, but individual students are not required to participate. Beginning in 2017–2018, MDE will only reimburse districts for students who are eligible for a free or reduced-price meal.

While a school district may require a student who is not eligible for a free or reduced-price meal to pay the cost of taking a nationally recognized college entrance exam, these charges create barriers to student participation. MDE encourages that whenever possible, fees should be avoided.

A district may not charge a fee to a student who is unable to pay for the college entrance exam. The legislation did not provide for a specific reimbursement to districts for students unable to pay. Further, no criteria was provided to determine ability to pay, so districts can determine who falls in the category of unable to pay. MDE may reimburse districts on a prorated basis for students that are unable to pay for the exam. We will not know if there will be funds available until reimbursements are made for students qualifying for free and reduced-price meals. Districts will indicate in the GRR system those students for which they are requesting reimbursement based on the students unable to pay.

Updates to Scores for ACCESS and Alternate ACCESS for ELLs

On Oct. 5, the Achievement Level field of the District and School Student Results (DSR & SSR) and the Student Assessment History Report for ACCESS and Alternate ACCESS will be expanded to three characters to allow a decimal. If your district imports the data into another system that is set up to read the proficiency level as one character, it should be updated to receive three characters.

Note: The information in the Achievement Level field will be the same as what you will see in the Score2 column (for ACCESS), which is the Proficiency Level. For ACCESS and Alternate ACCESS, the Achievement Level and the Proficiency Level are the same score. After the change is made, achievement levels for all assessments will be in the same column.

The update will include changes to other columns in the DSR/SSR as well. All the original data will be in the same location in the file, but more fields will have data, and some of the field names will change. These changes are in response to new accountability requirements, new student designations (e.g., Recently Arrived English Learner), and program changes (e.g., use of Quantiles). See table below for a list of the columns that are changing.

Individual Student Reports (ISRs) were delivered to districts on Aug. 7. ISRs are the official paper reports that must be provided to families no later than fall conferences. If ISRs have not yet been distributed, districts will need to determine how and when they will provide them. During Pretest Editing in Test WES, districts will confirm the timely delivery of ISRs.
