MDE DAC Test Administration Training Participation

Each year, MDE provides DAC Test Administration Training to prepare DACs for the upcoming test administrations. All DACs are required to participate in the MDE webinar or view the recording posted to the Training Management System (TMS) (on the Districts Assessment Coordinator tab under MDE Recorded Webinars). DACs who attended the virtual training (on either Dec. 14 or Dec. 20) will have a completed training listed on their record of completed training in the TMS by Jan. 6. For those viewing the recording, participation will appear upon completion.

Note: In order to be considered as participating in the MDE webinar, participants must have attended at least 80% of the webinar. If you attended the webinar but were unable to be there for the entire time, view the recording to document completion.
