District Test Security Procedure

Each school district must have a written district test security procedure that addresses how test security policies and procedures will be implemented. This procedure must be reviewed and updated annually, as needed, before training or resources on district-specific policies and procedures is provided.

The *District Test Security Procedure Requirements* in Appendix B of the <u>Procedures Manual</u> contain a list of the specific topics that must be minimally addressed in the district test security procedure, including a comprehensive list of the policies and procedures that each district must determine. Note: There were no additions to this list for 2021–22.

Districts can use the sample district test security procedure template available on the <u>PearsonAccess Next</u> website or create their own procedure. However, MDE strongly recommends using the template in order to ensure all requirements are addressed completely. Districts that have used the template tend to receive fewer recommended changes or required actions during MDE's review of their test security procedures.

- All statewide assessments administered in the district (MCA, MTAS, ACCESS, and Alternate ACCESS) must be reflected in the procedure. If procedures vary by assessment, this must be noted.
- Districts must specify policies by school, if they vary, and can include additional documentation as needed for their district. DACs may also have School Assessment Coordinators or other school staff complete the procedure for their school and return it to the DAC for documentation.
- Roles (e.g., DAC, principal) or individual staff member names should be included to specify who is responsible for the given tasks.

2021–22 College Entrance Exam Requirement

As in past years, districts are required to offer a nationally recognized college entrance exam (ACT or SAT) to grades 11 and 12 students during a 2021–22 school day. Districts must enter into a contract directly with the test vendor. The requirements for offering a college entrance exam have not changed and are detailed in the *Procedures Manual*. More information about ACT and College Board is included below.

ACT

- Districts will need to provide ACT the percentage of students that are eligible for free or reduced-priced meals to determine if the district will get a reduced price from ACT.

Independent Contractor Opportunity: MTAS Field Auditors

Each year, MDE employs Field Auditors to observe MTAS administrations in selected schools around the state in order to gather evidence and evaluate the validity and reliability of the assessment. MTAS Field Auditors serve as evidence-gatherers; their job is to obtain evidence that will determine 1) the extent to which the training of the administration was properly implemented and 2) the consistency of the administration for students across the state. For 2021–22, MDE is looking for auditors who can commit to work with MDE between 4–7 days of work from February–May 2022.

MTAS Field Auditors must be able to travel within an approximate 100-mile radius of their home area and have the following qualifications to serve on behalf of MDE:

Minimum Qualifications

- Current or retired educator or administrator, with Minnesota licensure
- Experience working with students with disabilities in an educational setting
- Three years of classroom experience
- To protect, to the extent reasonably possible, the health and safety of employees, school staff, and students from the direct threat resulting from the spread of COVID-19 in the workplace and to members of the public, MDE employees and contractors must provide proof of full vaccination against COVID-19 or weekly negative COVID tests

Desired Qualifications

- Current or retired teacher or administrator with special education licensure or endorsements, particularly those for teaching students who would likely qualify for the MTAS (e.g., Developmental Cognitive Disability certification)
- Experience working with students with significant cognitive disabilities in an educational setting
- Five years or more of classroom experience
- Previous experience with the MTAS as a Test Administrator or Field Auditor
- Familiarity with ESSA and IDEA policies and requirements
- Access and ability to use email, the Internet, and Microsoft Word and Excel. The email address must be accessible only to the auditor for student privacy reasons.

Upcoming COMPASS Learning Opportunities

Collaborative Minnesota Partnerships to Advance Student Success, <u>COMPASS</u>, is a new statewide education system that is a collaboration between the Minnesota Department of Education (MDE), Minnesota Service Cooperatives and Regional Centers for Excellence. COMPASS is designed to meet schools and districts where they are in the work to accelerate student learning and match the state's response to those needs.

Throughout the 2021–22 school year and beyond, educators, school staff and school leaders will have new opportunities for professional learning and coaching, along with coordinated support from experts. Schools will gain support in the areas of Literacy, Math and School Climate and Mental Health using the Minnesota Multi-Tiered System of Support (MnMTSS) framework with a focus on data and assessment literacy and evidence-based practices.

The first supports for schools available through COMPASS will be available in November, beginning with a two-part Minnesota Multi-tiered System of Support (MnMTSS) Overview webinar.
