2023–24 College Entrance Exam FRP Reimbursement

Districts are required to offer a nationally recognized college entrance exam (ACT or SAT) to grades 11 and 12 students during a 2023–24 school day. Districts must enter into a contract directly with the test vendor. While a district may offer other assessment options to students at their discretion (for example, ASVAB or ACCUPLACER), a college entrance exam must still be offered. The requirements for offering a college entrance exam have not changed and are detailed in Chapter 2 of the *Procedures Manual*.

MDE reimburses districts for students who are eligible for free or reduced-price meals (FRP) (in addition to students who are determined to be unable to pay). To be eligible for reimbursement under FRP, the student must have been identified in student enrollment data as eligible for FRP at some point during the school year the exam is administered. The reimbursement criteria has not changed with the passing of the Free School Meals for Kids Program. Refer to the Free School Meals for Kids Program for more information, including an FAQ that includes information about collecting Applications for Educational Benefits.

Student Records in ACCESS Precode File

For ACCESS and WIDA Alternate ACCESS, only one precode file is sent to DRC annually to load student data into WIDA AMS for online testing and to create student labels for paper test materials. This precode file was pulled last week to send to DRC.

New validations required by DRC required that a dual-enrolled student's information be sent for precode for only one of the schools, which means that only one school and/or district will have the student's information sent. The same hierarchy used to select a record for MCA/MTAS precode was used to determine which school was selected. Refer to the appendix of the <u>Test WES Precode User Guide</u> for more information. Students can be manually entered into WIDA AMS If a student was not sent in the initial precode file for your school and you will be testing the student.

Test Security Desk Audits

The MDE Test Security and Data Integrity (TSDI) program is currently conducting desk audits of district level test security procedures, online assessment calendars, and usage of the medical excuse (ME) test code during the 2023 spring administrations. These desk audits are one way that TSDI works with districts to ensure requirements found in statute and/or the <u>Procedures Manual</u> are being carried out. The audits also identify opportunities where improvements could occur.

Desk audits are created by TSDI as a new Assessment Security Record in Test WES, and emails are sent to the DAC and Superintendent/Director to notify the district that TSDI is requesting an action. Documentation, feedback, and other communication related to the desk audits will be attached the record.
