## **Testing Windows Closing**

## Reading and Mathematics MCA and all MTAS (Reading, Mathematics, and Science)

### **Online Testing and Data Entry Deadlines**

**This Friday, May 5**, is the last day of the testing window for Reading and Mathematics MCA and all MTAS subjects, **including Science MTAS**. Pearson does not score any paper test materials, so districts must ensure that all student responses or MTAS scores are entered online in order to be scored.

Districts must enter accommodations or change test assignments from MCA to MTAS in Test WES by this Thursday, May 4, in order for the updates to appear in PearsonAccess Next by the last day of the testing window.

#### **Reading and Mathematics MCA**

• All Reading and Mathematics MCA online testing must be completed by 5 p.m. this Friday, May 5.

- All student responses from Reading and Mathematics MCA paper test books must be entered in TestNav by 7 p.m. this Friday, May 5.
- Test codes (such as refusals) for all MCA subjects can be indicated in PearsonAccess Next until 7 p.m. on Friday, May 12.

### Reading, Mathematics and Science MTAS

- Data for *all subjects* of MTAS (Reading, Mathematics, *and* Science) must be entered in PearsonAccess Next by 7 p.m. on **this Friday, May 5**.
- Test codes (such as refusals) for MTAS must be indicated in PearsonAccess Next by Friday, May 5.

#### **MTAS Data Entry Reminders**

If a student's MTAS on-demand report has an NC (Not Complete) code, this means that not all data was entered for that student's test. If the data was entered incorrectly, contact the Pearson help desk at 888-817-8659 to reset the test. Refer to the MCA/MTAS Irregularities for more details.

If a district wants a test code to be assigned to an MTAS record, it is important that the test code is indicated in PearsonAccess Next for MTAS. Since absent (ABS) and not enrolled (NE) test codes cannot be entered in PearsonAccess Next, a blank MTAS test for the applicable subject(s) must be submitted during the testing window and the applicable test code added during Posttest Editing. If a district waits until Posttest Editing, a test code can only be added to a blank assessment, which defaults to MCA and cannot be changed to MTAS at that time.

## Science MCA Online Testing and Data Entry Deadlines

May 12 is the close of the testing window for Science MCA. All online testing for Science MCA must be completed by 5 p.m. on May 12. All student responses in paper Science MCA paper test books must be entered in TestNav by 7 p.m. on May 12.

Note: As indicated above, **this Friday**, **May 5**, is the last day to enter Science MTAS data.

#### Manually Adding Students and Updating Information in Test WES for the Science MCA

May 11 is the last day to manually add students in Test WES, and also the final date to change the send indicator for high school Science MCA and to indicate accommodation/linguistic support codes for the Science MCA in Test WES.

## **MDE Systems Upcoming Maintenance**

MNIT will shut down most MDE production web applications and report systems this **Friday, May 5, at 5 p.m**. All MDE applications and systems are expected to be back up on Monday, May 8, at 8 a.m.

This maintenance will affect Test WES and Graduation Requirements Records (GRR). Districts won't be able to make any Pretest Editing or Precode changes in Test WES from 5 p.m. on Friday until MDE systems are back online the following Monday.

Note: This maintenance may affect the precode file scheduled to be sent to Pearson on Friday, May 5. Manually added students and changes made in Pretest Editing (such as accommodations, test assignment, linguistic supports, or send indicator) scheduled to be loaded to PearsonAccess Next on Monday may not be loaded until Tuesday, May 6.

## Graduation Requirement Records (GRR) Q&A Session

Our Graduation Requirement Records (GRR) Q&A session has been rescheduled for Tuesday, May 9, 2–3 p.m. Register for the GRR Q&A Session. This session will focus on submitting reimbursement requests for college entrance exams using the GRR system. The prerequisite for the GRR Q&A session is completion of the Graduation Requirement Records (GRR) Training, which is posted in the Training Management System (TMS).

MDE collects questions from DACs prior to the event to help prepare and find relevant resources to share. After completing the prerequisites, please <u>submit questions for the GRR Q&A Session</u>. Q&A Sessions will not be recorded nor will CEUs be provided as these are an additional support rather than a training event.

## **Returning Secure Test Materials**

Secure test materials must be returned to Pearson via UPS after the tests are administered and student responses and MTAS data are entered online. These secure test materials do not need to be held until the end of the testing window if testing is complete. Note that MTAS Learner Characteristics Inventory (LCI) and Data Collection Forms must stay on file at the district for one year.

To ensure materials are received by the deadline, work with your schools to confirm that all materials are returned in a timely manner. Depending on your process, materials at schools may be sent to the district for return or directly to Pearson. All materials must be shipped no later than May 15.
