Final Assessment Results Release Tomorrow

Assessment and accountability results will be released to the public tomorrow, Aug. 24. To accommodate the release of the 2023 results, the Minnesota Report Card is unavailable today. If users try to access the Minnesota Report Card today, a message will appear regarding the temporary site closure.

District leaders and District Assessment Coordinators received an email from MDE this afternoon with the press release and links to the embargoed statewide accountability and assessment files. The same information will be provided to the media. This is information is being shared with districts today so that you can prepare for local reporting.

After results are released publicly, assessment results information will be available in two places on the MDE website for families, educators, and community members to access.

• The <u>Minnesota Report Card</u> allows users to create graphs and tables to view results for various groups of students across the state as well as within districts and schools. A <u>Minnesota Report Card User Guide</u>

(select Using the Report Card menu choice) provides information on interpreting and using the data on the Report Card.

 Downloadable data files are under <u>Assessment Files</u> (MDE website > Data Center > Data Reports and Analytics), which provide summary assessment data for the state, county, districts, and schools that can be used to perform analyses. The <u>Assessment Files User Guide</u> (linked in the overview paragraph located at the top of the Assessment Files page) provides information about the content of the files; information is also available on the first tab of the files.

Embargo Reminder

Until released publicly tomorrow, results are still considered embargoed. During the embargo, districts may share the results with district teachers and staff for planning or instructional purposes but may not share the summary results in public settings. Districts can also use the final embargoed results to prepare for questions from the media and local stakeholders, but if a media outlet contacts a district before the public release of results, the district should redirect them to the MDE Communications division. Final Individual Student Reports Delivery and Video ISRs

Final Individual Student Reports (ISRs) for both MCA/MTAS and ACCESS/WIDA Alternate ACCESS are scheduled to arrive in districts tomorrow, Aug. 24. Since ISRs contain private student data, **it is important for districts to ensure someone is available to receive the reports and secure them until distribution**. The final reports shipment will be sent to districts, and each school will have its own box labeled with the school's name. For nonpublic schools, final reports will be packaged and shipped directly to each school. Refer to last week's *Assessment Update* for links to available resources and detailed information on the contents of each shipment of ISRs.

Personalized video ISRs for students with MCA and MTAS scores will also be available on Aug. 24. These videos include an overview of the assessments and the student's performance in each subject taken, as well as their performance related to the school, district, and state averages. In addition to English, video ISRs may be available in a home language based on student enrollment data, if specified (Amharic, Arabic, Chinese, Hmong, Karen, Oromo, Russian, Somali, Spanish, and Vietnamese). Parents/guardians can access video ISRs by scanning a QR code on the ISR with a smart device or by contacting their student's school for a link to access the video report. On Aug. 24, video list files (csv) with links for video ISRs for students with scores will be available at the

school or district level under Published Reports in PearsonAccess Next. A <u>Video ISR FAQ</u> document is now available on PearsonAccess Next.

Finding Reports in WIDA AMS

As you prepare to receive printed reports for the ACCESS and WIDA Alternate ACCESS on Aug. 24, please be aware that some reporting features in WIDA AMS have been relocated as part of the recent system update. All score reports from 2021–22 and 2022–23 can still be found under Report Delivery. This includes English and translated versions of 2023 ACCESS and WIDA Alternate ACCESS Individual Student Reports (ISRs). Reports from 2023–24 are now located under Reporting Services. This includes English and translated versions of the WIDA AMS landing page button labeled "Download Individual Student Reports" will take you to Reporting Services. Report Delivery is accessed by selecting the "My Applications" dropdown menu at the top of the WIDA AMS website. Cell Phone Policies

Several districts are in the process of updating their own cell phone policies and some are providing more discretion for cell phone allowance and usage at the classroom level. If your district is in the process of enacting or considering changes to your cell phone policy, please make sure to inform your district leadership of the following as it relates to statewide assessment policies and procedures:

- Access to cell phones and other prohibited electronic devices described in the <u>Procedures Manual</u> is not allowed during administration of statewide assessments. Note: The 2023–24 Procedures Manual will not be posted until early October, but the policies and procedures related to cell phone and device usage have not changed.
- Districts are required to develop and include in their test security procedures their own procedure for ensuring students do not use or have access to cell phones or other prohibited electronic devices during administration of statewide assessments.
- While districts may allow classroom teachers to determine their own classroom cell phone policies for instruction, no classroom teacher has the authority to allow a student to access a cell phone and/or use it for statewide assessments.
- A student who uses a cell phone while taking a statewide assessment will have their test invalidated.
- The specific and extremely limited situations for when a prohibited device can be partially accessible during administration of statewide assessments, such as when used as a medical device, are described in the *Procedures Manual*. Information regarding how to investigate an incident where a cell phone or other prohibited electronic device may have been used during the administration of a statewide assessment and guidance on how to review the device for a potential content breach can be found in the *Prohibited Electronic Devices Investigation Guide* in Appendix B of the *Procedures Manual*.
