Confirm Shipping Address for Final Reports

As Pearson prepares to distribute Individual Student Results (ISRs) to districts in late August for the MCA/MTAS, it is important that districts confirm the correct address is listed in MDE-ORG by end of day tomorrow, July 14. Unless there is an Assessment Shipping Address indicated, Pearson will send ISRs to the district's physical address that is indicated in MDE-ORG. If testing results should be sent to an alternate address, the Assessment Shipping Address should be added or verified. Note that UPS will not deliver to a PO Box. The district's Site Verification Coordinator (SVC) maintains the information in the District and School Site Verification system. DACs should work with their SVC for any needed changes.

For ACCESS/Alternate ACCESS, DRC will ship paper reports to the district's mailing address MDE provided last September. Contact DRC at www.willows.com or 855-787-9615 no later than July 30 to indicate an address change.

New Pathways to Exit EL Status

As communicated in the May 18 *English Learner Education Updates* and *Assessment Update* newsletters, additional pathways to exit English learner (EL) status have been approved:

- Exit criteria for students who cannot complete all four domains of ACCESS
- Pathway to exit for students who participate in Alternate ACCESS

As needed, MDE contacts districts where a student is eligible based on exit criteria for students who cannot complete all four domains. If you were not contacted, you did not have students eligible based on this pathway.

Districts make their own determinations for Alternate ACCESS based on the information provided in the May 18 communications. If you have questions regarding the new exiting pathways, contact mde.el@state.mn.us.

- Subscore Reports on the <u>Subscore Reports</u> page of the PearsonAccess Next website.

All current Longitudinal Reports, Historical Student Data, and Subscore Reports will again be available on Aug. 25.

Call for Assessment Inventory Examples to Spotlight Districts and Schools

In the <u>June 8 Assessment Update</u>, MDE called for schools and districts asking them to be featured in the <u>Minnesota Data and Assessment Literacy (MnDAL)</u> on-demand learning modules.

If you have been taking stock of the assessments students take in your district or school as a way to evaluate the extent your assessments are coherent, useful and efficient, MDE would like to feature your efforts! In addition, if you have attempted or started a process to evaluate what type of assessment information stakeholders at various levels need to advance learning while avoiding misalignment and over-testing, MDE encourages you to share your approach and key findings. Sometimes this process is called an assessment inventory or audit, and is done using various tools at the school or district-level.
