## ***Accountability System Updates and Key Dates***

On March 2, 2022, the Minnesota Department of Education (MDE) submitted to the U.S. Department of Education an amendment to Minnesota's state plan under the Every Student Succeeds Act (ESSA). The proposed changes were developed after engaging with community organizations, educators, and school and district leaders followed by a public comment period.

The amendment was revised based on requirements from the U.S. Department of Education and was approved on July 1, 2022. The final, approved amendment includes multiple changes to the state's accountability system. Some of these are temporary changes in response to the COVID-19 pandemic's effects on the availability and quality of data, and some are changes that community members, educators, and school and district leaders have been requesting since the initial approval of Minnesota's ESSA state plan in 2018.

Two webinars to discuss the changes and review this summer's accountability data release schedule will be held in early August. Additional webinar opportunities will be offered closer to the Aug. 25 public release date.

### **Key Dates for Accountability**

- Aug. 8: Schools and districts receive secure local accountability data; accountability appeals window begins.
- Aug. 12: Accountability appeals window closes.
- Aug. 23: Schools and districts receive embargoed accountability summary data for the entire state.
- Aug. 24: Media receive embargoed accountability summary data.
- Aug. 25: Public release of final assessment and accountability results.

## ***District Testing Calendar***

Districts are required to post a comprehensive testing calendar on the district website **before** the first day of the school year; this information may also be posted on school-level websites if the district chooses. Districts may choose how to display the information (for example, in a chart or a calendar format), but it should be presented in a way that is as easy to access as possible. Core requirements for the district testing calendar have not changed and are detailed in the [Procedures Manual](#), starting on page 121.

If a district has not yet established specific dates when students will be testing, MDE recommends using previous years' timeframes as a starting place and then updating them as schedules are known or changed.
