

Published Reports Quick Guide

This guide provides instructions on downloading published reports in PearsonAccess Next. Note: The individual student information available in the secure PearsonAccess Next system is private student data. Ensure student data privacy is maintained when accessing, printing, or sharing information from the system.

Note: The first administration of Science MCA-IV and Science Alt MCA was in 2024–25, and standard setting will follow. Final reports for science will be available on Oct. 1. Final reports for reading and mathematics will still be available in late summer (Aug. 22).

Access by User Role

Users with the District Assessment Coordinator (DAC) or Assessment Administrator (AA) role in PearsonAccess Next have access to Published Reports.

| Labels | Final | MCA, MTAS, Alt MCA | Student results labels in PDF format provide test score information for students participating in the assessment that can be printed; the report is posted by school. To print the PDF labels, use a 12 label sheet with 4" x 1.5" labels (for example, Avery label #5197). Labels may also be printed on a single label sheet and manually cut by the district. | 2023–2025 Labels with combined results for reading, mathematics, and science are available Oct. 1. |
| Benchmark Reports | Final | MCA | A report comparing observed performance on the MCA at the school or district to the expected performance at the "Meets" achievement level cut score for a benchmark; the report is posted by district and school. New for 2024–25: Science MCA benchmark reports are not available due to the transition to a new assessment. | 2019, 2021–2025 Reading and mathematics reports are available Sept. 3. Historical Science MCA benchmark reports are still available for 2019, 2021–2024. |
| ISR Video List | Final | MCA, MTAS | For reading and mathematics, a spreadsheet containing hyperlinks to video ISRs for each student with at least one valid score; the report is posted by school and district. ISR videos are not created for students with only non-valid scores (such as, REF-S, REF-P, INV-S, INV-O, INV-D, ME, ABS, NA, NC, or NE). The science video is an overview that is not personalized for student results for 2025. | 2023–2025 Reading and mathematics ISR video reports are available Aug. 22. A science overview video is available Oct. 1. |

Administration Reports: The following reports provide test administration information in Published Reports for the most recent test administration and are available to DACs only:

- The Secure Materials Status Report lists secure test materials for MCA and MTAS/Alt MCA that have not been
 returned to or scanned by Pearson. For more information, refer to <u>Accessing the Secure Materials Status Report</u>
 (PearsonAccess Next > Resources & Training > User Guides).
- The **Testing Time Report** is available at the district-level and provides cumulative testing time information by student. The time (in seconds) indicates the total time a student spent on both scorable and non-scorable (for example, student directions, section end pages, start of section, etc.) items. This report is intended to provide districts information to plan for future administrations by confirming the amount of time students tested, or to identify trends by grade or subject across the district. The data provided in this report is not meant to be used to make decisions about individual students. Note: The Testing Time Report is only available for MCA.



Verify Test Administration

Once you are signed into PearsonAccess Next, verify the applicable test administration is selected. To change the test administration, select the administration dropdown at the top and select a different year and test name.



View Published Reports

1. From the Home page, under **Reports**, select **Published Reports**.



- 2. To narrow the list of reports, search under **Find Reports** or use one the **Filters** on the left to find the report needed.
 - Under **Find Reports**, enter the file name (type in the partial or full name) and select **Search**.

Note: Published reports are ordered by date posted to PearsonAccess Next with the most recent reports listed first.

- Use one or more of the Filters:
 - Organization Type (select district, school, or nonpublic school)
 - Organization Name (type in partial or full name) Note: Your assigned organization will be automatically populated in this filter. If your assigned organization is at the district level, remove this filter selection to see school-level reports.
 - Published Report Date Range (mm/dd/yyyy)
