Embargoed WIDA Alternate ACCESS Summary Results

On Tuesday, Oct. 8, embargoed WIDA Alternate ACCESS results will be available in Test Results Summary on the <u>Secure Reports</u> page of the MDE website. WIDA Alternate ACCESS results continue to be under embargo until Oct. 22. During the embargo, districts may share the results with district teachers and staff for planning or instructional purposes but may not share the results publicly.

The following resources are available to support districts:

As a reminder, information on WIDA Alternate ACCESS Exit Eligibility was shared in the July 31 <u>Assessment Update</u>, and information on embargoed WIDA Alternate ACCESS results was shared in the Sept. 18 <u>Assessment Update</u>. DACs are requested to share exit eligibility and test results for the WIDA Alternate ACCESS with the appropriate EL staff. Deadline for MCA and MTAS Late Score Entry or Rescore Requests

The deadline for late score entry or rescore requests for spring 2024 MCA and MTAS testing is Oct. 9.

The Request for Late Student Response Entry Form can be found on page 313 of the <u>Procedures Manual</u>. These requests can be made if a district did not enter a student's MTAS scores or responses from an MCA paper test book in PearsonAccess Next during the testing window. Contact Pearson at 888-817-8659 or <u>submit a Pearson help desk request online</u> with further questions. Note: For late score entry requests received at this time, students will not receive an Individual Student Report (ISR), but districts can request that Pearson provide an On-Demand Report for the student.

A rescore may be requested when a parent/guardian or school district staff disagrees with the final score a student received (typically for an MCA paper administration). Note: Items for online administrations are reviewed multiple times before and during testing for scoring accuracy and unanticipated responses. Because of MDE's rigorous item review process, a rescore is highly unlikely to result in a score change for an individual student. If a discrepancy is found for an online item during a scoring review, scores will be updated for all affected students. DACs must email mde.testing@state.mn.us with the student's MARSS/SSID number and the rationale for requesting a rescore, and MDE will review the request. If approved, the cost for rescoring a test is \$125 per test. A rescore does not include test or score code changes (INV, NC, REF-S, etc.).

2024–25 College Entrance Exam Requirement

As in past years, districts are required to offer a nationally recognized college entrance exam (ACT or SAT) to grades 11 and 12 students during a 2024–25 school day. Districts must enter into a contract directly with the test vendor. While a district may offer other assessment options to students at their discretion (for example, ASVAB or ACCUPLACER), a college entrance exam must still be offered. The requirements for offering a college entrance exam have not changed and are detailed in Chapter 2 of the *Procedures Manual*. More information about ACT and College Board is included below.

ACT

Districts can view administration information, Free/Reduced Lunch Program (FRLP) pricing structure, and key testing dates and deadlines on the <u>ACT District Testing</u> page of the ACT website.

In order to determine if the district will get a reduced price from ACT, districts will need to provide ACT the percentage of students who are eligible for free or reduced-priced meals.

Data and Assessment Literacy Community of Practice Series

District Testing Calendar Reminder (repeat)

Districts are required to post a comprehensive testing calendar on the district website; this information may also be posted on school-level websites if the district chooses. The calendar must be published at least one week prior to any eligible assessments being administered, but no later than Oct. 1. Districts may choose how to display the information (for example, in a chart or a calendar format), but it should be presented in a way that is as easy to access as possible. Core requirements for the information that must be included on the district testing calendar have not changed and are detailed in Chapter 6 of the <u>Procedures Manual</u>.

If a district has not yet established specific dates when students will be testing, MDE recommends using previous years' timeframes as a starting place and then updating them as testing schedules are known or changed. Districts should keep their testing calendar up to date throughout the school year.

Opportunity for District SIS and Data Warehouse Vendors (repeat)

For the spring 2025 test administrations, Student Information System (SIS) and data warehouse vendors will have the opportunity to receive regularly scheduled extracts of preliminary on-demand data for the Reading and Mathematics MCA and Reading and Mathematics MTAS during the testing window and/or final data extracts for all subjects of MCA and MTAS/Alt MCA and ACCESS/WIDA Alternate ACCESS following the release of the DSR/SSR files. These extracts allow vendors to load the data directly into their system for access by schools and districts. To participate in this service, districts and charters must enter into a data sharing agreement with their associated vendor and MDE. Vendors will be given the option of receiving preliminary data, final data, or both on behalf of their member districts. Vendors need to commit **no later than Friday, Oct. 18.**

The SIS and data warehouse vendors must configure their system to receive the preliminary data in the file layout provided by Pearson. A file layout for the final results will also be provided to participating vendors by MDE.

Upcoming Opportunities

Register for New DAC Orientation (repeat)

In October, MDE and Pearson will present the New DAC Orientation, which will provide an overview of the various roles and responsibilities of a District Assessment Coordinator (DAC), the statewide assessments administered in Minnesota, relevant MDE and WIDA systems, available resources, and upcoming training opportunities. Pearson will provide information on their systems and available resources. While this training is specifically designed for new DACs, experienced DACs are also welcome to attend.

MDE is offering this training in three formats: an all-day, in-person training event in Northeast Minneapolis, a two-part series of live virtual trainings on back-to-back days, and pre-recorded trainings that will be posted in the Learning Management System (LMS). Please note that there are space limitations for the Oct. 10 in-person training, so early registration is suggested.
