## ***New Guidance on Administering WIDA Screener to Students who are Blind/Visually Impaired and/or Deaf/Hard of Hearing***

A new guidance document is available to provide WIDA's recommendations for IEP/504 plan teams to consider when administering WIDA Screener to a student who is blind or visually impaired (BVI), or who is deaf or hard of hearing (DHH).
