Embargoed WIDA Alternate ACCESS Student Results in Secure Reports

Final student-level WIDA Alternate ACCESS results are scheduled to be available in the <u>District and School Student Results</u> (DSR and SSR) files on Sept. 24. These results will be under embargo until the public release of assessment results on Oct. 22. It is up to the district to determine whether to share embargoed assessment data with students, families, and staff for instructional purposes. Preliminary or embargoed results cannot, however, be discussed in public forums, reflected in public meeting minutes (such as school board meetings), or shared with the general public or media until the final assessment results have been released publicly.

Please keep the following points in mind as you review your WIDA Alternate ACCESS results:

• The 2023–24 WIDA Alternate ACCESS is a completely updated assessment. As such, scores from the 2023–24 WIDA Alternate cannot be compared to prior year scores on the Alternate ACCESS.

- WIDA Alternate ACCESS will not be included in accountability for 2023–24. The Progress Toward English Language Proficiency accountability indicator requires two years of scores to determine growth. Last year's scores are not based on the standards assessed by the new assessment; therefore, last year's scores cannot be used to determine progress.
- While two years of results on the new scale are needed to look at growth, three or more years are needed to see trends in language development.
- Use the new <u>Alternate Proficiency Level Descriptors</u> and guidance in the <u>Interpretive Guide for Score</u>

 *Reports to:
 - Identify student strengths
 - o Determine appropriate student supports
 - Look ahead at the next proficiency level to set language goals

Updated District Policies and Procedures for Statewide Assessments Template

Each year, districts are required to have written District Policies and Procedures for Statewide Assessments that address how test security policies and procedures will be implemented. Note: This procedure has been renamed for clarity (previously titled Test Security Procedure). Districts may create their own procedure or use the template available on the <u>Policies and Procedures</u> page of the PearsonAccess Next website. The template has been updated with minor language clarifications, including adding references to the new Alternate MCA.

The MDE Test Security and Data Integrity (TSDI) team will select a sampling of districts and review their district policies and procedures beginning in October. The TSDI team will then provide feedback and may recommend changes and/or require action. Districts are randomly selected, and DACs at selected districts will be contacted in mid-October with a request for a copy of their District Policies and Procedures. Even if your district is not contacted for an MDE review, ensure your district policies and procedures is in place before testing begins for 2024–25.

Translated ISR Quick Guides

Translated versions of the MCA and MTAS *Individual Student Report Quick Guides* will be available in early Oct. on the Translated Documents section of the <u>Students and Families Statewide Testing page</u> of the MDE website. English versions of the Quick Guides can currently be found on the <u>District Resources page</u> under the Test Score Interpretation Resources expandable header.

The division of Academic Standards, Instruction and Assessment strives to translate as many parent and guardian resources as possible into the ten most populous languages spoken by Minnesota students. The current languages are Spanish, Somali, Hmong, Karen, Vietnamese, Arabic, Chinese (Mandarin), Russian, Oromo (Afan Oromo, Oromiffa), and Amharic. This data is from 2020–21 and is reevaluated every five years. Note that some resources are translated into the top three languages (Spanish, Somali, and Hmong) only.

New DAC Orientation - Save the Date

MDE and Pearson will host New DAC Orientation in October. This training will provide an overview of the various roles and responsibilities of a District Assessment Coordinator (DAC), the statewide assessments administered in Minnesota, statewide assessment systems, available resources, and training opportunities for the 2024–25 year. While this training is specifically designed for new DACs, experienced DACs are also welcome to attend.

New DAC Orientation will be offered in three formats: a two-part virtual training sessions spread over two days (9–11 a.m. on Tues., Oct. 8, and Wed., Oct. 9), an all-day in-person training event in Northeast Minneapolis (9 a.m.–3:30 p.m. on Thurs. Oct. 10), and a pre-recorded training that will be posted on Fri., Oct. 11 in the <u>Learning Management System (LMS)</u>.

Science Alternate MCA Kickoff Meetings

This fall, MDE will be hosting regional in-person and online Science Alternate Minnesota Comprehensive Assessment (Alt MCA) Kickoff Meetings focusing on:

- The preparation and administration for Spring 2025 Science Alt MCA operational assessment
- Tools for making decisions about student administration formats (online, paper or hybrid)

- Revised Learner Characteristics Inventory
- Revised Alternate Assessment Eligibility Requirements
- Diving into the test design and extended benchmarks aligned to the Alt MCA
- In-person sessions will include interactive activities to engage with the Alt MCA materials

These kickoff meetings will focus on one-on-one administration activities and are geared for MTAS/Alt MCA Test Administrators. However, District Assessment Coordinators (DACs), Special Education Directors/Coordinators, and any district staff involved in administering alternate assessments are also welcome to attend. MTAS/Alt MCA information meetings will also be offered in January to focus on providing updates for the upcoming Spring 2025 administration.
